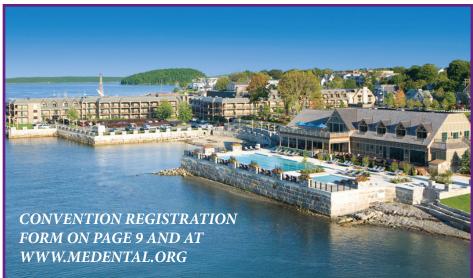

In keeping with notification requirements, all members are receiving this notification 30 days in advance of the Maine Dental Association Business meeting, which will be held on:

Date: June 2, 2017 Time: 4:45 p.m.

Location: Harborside Hotel, Spa, and Marina, Bar Harbor

Summary of the proposed bylaws changes:

- On page 3, Chapter I: Membership, Section 50, item G. Non-resident members' annual dues increased from \$50.00 to \$75.00
- On page 6, Chapter IV, Executive Board, Section 30.
   Powers: An electronic voting provision for the Executive Board
- On page 6, Chapter IV, Executive Board, Section 40.
   Duties: new language to update the names of the standing councils to committees/ task forces or fast action teams to reflect a shorter time limit of service in order to attract new volunteers to serve.
- On page 7, Chapter IV, Executive Board, Section 50:
   Quorum: specifies the Executive Board shall meet no fewer than five (5) times per year

 On pages 10-13, Chapter VII: Councils, Committees, and Consultants: title changed to Committees, Task Forces and Consultants. Names and committee descriptions

remain unchanged. Membership type requirements and terms generalized

As part of our efforts to revitalize the association, we are working to reduce barriers to participation in our association.

 On page 11, Chapter VII: Councils,

> Committees, and Consultants added Committee on Past Presidents to serve as repository of institutional memory and as an advisory panel

 On page 14, Chapter XI. Conflict of Interest language was added.

## ADA Bylaws Change Would Eliminate License Requirement

At its 2016 meeting, the ADA House of Delegates adopted a resolution that would amend the ADA Bylaws so that, beginning in the 2018 membership year, a dental license in a state is no longer an eligibility requirement for membership. A member must hold a DDS, DMD, or equivalent degree.

The reported intent of the revisions is to improve the member experience, minimize the barriers to joining, and increase the flexibility of making necessary changes in the future. One reported benefit of the changes is having new dental school graduates or residents being able to join before completing the licensure process.

States will need to make changes to their own bylaws in order to be in alignment with the changes, unless the matter is brought back to the 2017 House of Delegates.

engagement within our organization.

The shape of the Maine Dwwental Association is changing, as it should, in order to adapt to our member's needs. We are profoundly aware that faster technology, busier personal lives, as well as the impact of PPOs and legislation that threaten the way we practice, are all reasons why our association must remain dynamic in order to create relevant value to our membership. My website development and marketing team are constantly telling me, "sell the problem you solve, not the product," and I believe that the MDA demonstrates a commitment to finding solutions to these challenges. In the last few years, the dental profession has been coming under attack, as bills have been submitted by special interest groups.

However, time and effort put in by both our Executive Board, as well as member dentists around the state, who either wrote testimony or personally testified in Augusta, are how we have managed to prevent many of these bills from further dictating the way in which we practice and operate our businesses.

#### The Circle of Influence

I can't take credit for that phrase, it was something I heard Fred Joyal (the 1-800-Dentist guy) use during a lecture on marketing, about the ways in which small actions or behaviors can trigger an unknown, but positive, domino effect. So I was recently traveling through the Tampa airport to attend a CE and I wound up seeing Leaping Lanny Poffo, one of the aforementioned professional wrestling heroes from

my childhood. Of course I went up and introduced myself and he said, "Do I know you? Are you a wrestler?" When I told him I was a dentist, he said that I did not have a "dentist's hands." He then told me that he was flying out to do a book tour promoting some anti-smoking

limericks that he had written. Who would have imagined that a 80's wrestler is now an anti-smoking spokesperson and evangelizing to the next generation of kids on how to prevent oral cancer and overall health. When a professional wrestler is actively engaged in advocating for the oral health community, it really proves that there are no limits on who and how to become involved in something that is meaningful and important. The best part is he sent me a signed copy of his book for my waiting room.

#### My CTA (Call To Action) to All of You

This is more than just paying membership dues, or showing up to the annual convention, because participation, whether it is through attending CE, study clubs, or serving on a committee, all help build strong relationships that drive the sustainability and growth of our profession. Think about it; no one else can fully appreciate and understand

Greetings! I hope you are all as anxious for spring and warm weather as I am! I wanted to take this opportunity to let you know about recent updates.

At our February Board of Trustees meeting, the board approved the development of an objective structured clinical examination (OSCE), a type of high-stakes exam that evaluates clinical and critical thinking skills, widely used in health sciences, including optometry, medicine, nursing and physical therapy.

The Board directed that a pilot of the Dental Licensure Objective Structured Clinical Examination (DLOSCE) be available in 2019, and an exam deployment in 2020. Details of the exam — from content and structure to policies and staffing resources — remain in the works. The Board is creating a DLOSCE Steering Committee tasked to:

- Identify and establish content areas and test specifications for the examination.
- Conduct a practice analysis.
- Establish general structure for examination (number of stations) and permissible item formats (manikin, haptic feedback device, etc.).
- Identify and contract with key vendors, including technology and administration, in support of the exam.
- Identify and establish test construction committee structure.
- Develop the candidate guide.
- Call for test constructor applications.
- Identify appropriate governance structure for DLOSCE administration.
- Identify first state(s)/region(s) for the DLOSCE field test.

The DLOSCE will be a national exam, based on an analysis of U.S. dental practice. It will remain the same regardless of the region of the country where it is administered, and will become a third-party assessment of competencies regularly evaluated at accredited dental schools. Both the ADA Council on Dental Education and Licensure and the ADA/American Dental

Education Association Joint Licensure Task Force endorsed the initiative, which has been working closely on licensure issues over the past couple of years.

In December of 2015, the Council on Dental Education and Licensure recommended the development of a business plan for an OSCE. The development of the DLOSCE supports current ADA policy calling for the elimination of patients from the dental licensure examination process. In creating the business plan, the council and the Board considered advancements in high stakes clinical testing over the past 20 years and sought the expertise of the ADA Department of Testing Services, which received input from selected state dental boards during a forum at the 2016 ADA annual meeting in Denver.

Currently, only Colorado accepts an OSCE for initial licensure with no restrictions. Minnesota accepts the OSCE administered by the National Dental Examining Board of Canada for initial licensure, which is administered annually at the University of Minnesota for their graduates only. This type of dental exam has been given in Canada for many years and has proven to be a reliable way to test competency.

As a result of Resolution 67, which the House of Delegates passed in October 2016, the ADA is investing \$18 million in a three-year digital consumer advertising campaign to direct consumers to make an appointment with an ADA dentist. The <u>initial</u> focus of this campaign is a new ADA Find-a-Dentist tool launching in April, which provides consumers with a user-friendly experience and additional search fields to easily find an ADA dentist.

Before the marketing begins to consumers in May, make sure you get the full benefits of this campaign by updating your Find-A-Dentist profile. Just search "update your find a dentist profile" on ADA.org. Remember to include your photo, as pictures are a key factor to presenting a human face to potential patients! Recently, the ADA released its 2016 highlights video. Watching this video reminds me of the many, many benefits of ADA membership. It was an incredible 2016 and together we accomplished so much. I am proud to be a part of this wonderful organization and hope that you feel the same way after viewing it. Here is the YouTube link for the video - https://www.youtube. com/watch?v=tLfEGFX1ZU8. ## First ADA Dentist and Student Lobby Day A Success

This year, the American Dental Association combined its annual Dental Student Lobby Day with its Washington Leadership Conference to form the ADA Dentist and Student Lobby Day. It was held from March 26-28 in Washington D.C., and by all accounts was a great success! Representing the great state of Maine were three dentists, four dental students from UNE, and John Bastey from the MDA.

The ADA Dentist and Student Lobby Day focused on three main issues to discuss with our legislators on Capitol Hill.

H.R. 372 amends the McCarran-Ferguson Act to allow the full application of federal antitrust laws to be enforced against health and dental insurance companies when they are engaging in anticompetitive behavior. This passed in the House by a margin of 416-7 (and yes, both our House representatives voted with us), ensuring more competition will lower insurance costs, inspire innovation of ideas, and provide patients with greater options for insurance plans.

We also discussed ever-rising student loan debt. Did you know that the average dental student in the U.S. graduates with \$262,000 of student loan debt? And for many students who attend private dental schools that debt can greatly exceed that; upwards of \$400,000! So our students did a fantastic job speaking about their own experiences. explaining how this excessive debt load can preclude them from practicing in locations and settings in which they'd like to work, and how debt relief would help them become better contributors to the economy and provide more care to the patients who need it most. We asked that our delegation consider acts to allow multiple chances to refinance throughout the life of student loans, allow for subsidization of graduate school loans. and extend the period of deferment.

Although the Affordable Care Act reform bill had just been placed on the back burner when we spoke with our delegation, we also requested that when

considering further reforms to health care legislation, our elected officials work to preserve a comprehensive pediatric dental benefit under the Medicaid program, provide guidance to states in reducing administrative burdens for those providers enrolled with Medicaid, and promote transparency in the choices of insurance plans from which patients may choose on the market.

Having attended this meeting for three years, I have to say that this year was the most energetic, with close to 1,000 dentists and dental students gathered together to pool our efforts in lobbying our government officials. There were ample opportunities for networking with colleagues from other states, and voices from the Republican and Democratic parties united to form one "tooth party." The ADA developed an app to organize the events and to connect us all through social media, as well using the tag #toothparty. Next year's Dentist and Student Lobby Day has been scheduled already, with plans to keep the events



connected. Advocacy is SO important, at the state and national levels, and as always, it is an honor to represent our profession!

## UNE College of Dental Medicine To Graduate First Class

On May 20, the University of New England College of Dental Medicine will mark a milestone achievement as it holds commencement ceremonies for its inaugural graduating class. Sixty-two students will be awarded the doctor of dental medicine degree at UNE's 182<sup>nd</sup> Commencement Ceremony, held at 10 a.m. at Portland's Cross Insurance Arena.

Founded in 2013, the College of Dental Medicine is the first dental college in Northern New England. Of the 64 students in the college's initial class, 24 are from Maine, representing more than 20 different towns. The rest hail from 16 different states throughout the U.S, as well as Canada.

"We treat students as colleagues from the moment they arrive on campus and educate them in a humanistic, collegial manner throughout their journey," said Jay Beauchemin, DDS, assistant clinical professor and group practice leader at the College of Dental Medicine. "They are given state-of-the-art technology, real-world situations, and exposure to masterful faculty that allows them to progress at an impressive pace."

In the summer of 2016, this year's graduating class began their clinical rotations in communities throughout Northern New England. Working in Maine, New Hampshire, Massachusetts, Rhode Island, Vermont and beyond, they administered oral health care at a total of 27 sites, 16 of which are in Maine. Students on rotation provided 10,196 comprehensive dental visits to both children and adults, totaling 18,596 procedures at external sites, many of which are Federally Qualified Health

Centers in rural areas.

Jon Ryder, dean of the College of Dental Medicine, said "It is deeply gratifying to witness this graduating class entering the professional world – they have demonstrated remarkable dedication and hard work. I am honored to welcome them as colleagues in oral health care and I look forward to seeing the impact they will have on the many patients and communities they will serve."

The College of Dental Medicine's will also hold a hooding ceremony and reception at 3:30 p.m. on May 20. Graduates of the DMD program will receive their academic hoods representing the profession of dentistry.

## Changing Payment Methods Affect Your Bottom Line

2009 was one of the worst years for the economy in recent memory; the economy declined by 2.4% and, worse, the average dental office was hit by a 3.68% decline in the credit card processing volume



from the previous year. Per a 2014 ADA study, the dental industry has

yet to fully recuperate in the years since the Great Recession, as well as the rest of the U.S. economy. When adjusted for inflation, the net income of the average dental practitioner through 2013 had fallen by almost \$9,542 since 2009. This is a decrease of 5.01% from 2009 to 2013. There are many speculated reasons for this decline, including less demand for dental services combined with more practitioners entering the field. However, the sluggish pace of recovery is very real to MDA members.

Best Card, the Maine Dental Association's endorsed credit card processor, has compiled years' worth of financial data for dental offices nationwide which indicate that, while national dentistry growth after 2009 has been problematic, the percentage of payments paid using credit cards has risen sharply.

In 2009, the average dental practice processed \$15,221 per month in credit card sales compared to \$24,156 in 2016. This represents a growth of 58.7% in the average credit card volume for practices between 2009 and 2016. The lack of growth in the dental industry indicates that this growth is due to more patients paying for treatment using credit cards. There are many potential reasons for this, from evolving patient choice in payment methods to changes in the coverage and availability of patient insurance. However, the trend is clear.

The average transaction amount for dental offices increased by a small amount compared to the overall growth of card volumes. In 2009, in the depths of the Great Recession, the average

transaction for a dentist was \$256.85. In 2016, the average transaction was \$265.27. This represents an increase of 3.27% in the average transaction amount over nearly 8 years of data. While statistically significant, this has not affected the growth of monthly volumes nearly as much as the average number of transactions per month.

The single largest factor that has led to the increase in credit card processing volumes has been the average number of transactions per month. In 2009, the average dental practice ran 59.3 credit card transactions per month. In 2016, the average dentist ran 91.1 credit card transactions per month. This is an increase of 53.7% in the average monthly credit card transactions processed, which is a staggering increase over a seven-year period. Needless to say - when a sector of your business grows by more than 50%, you need to take a very close look to ensure that these changes don't negatively impact your bottom line!

Best Card offers the following tips to make sure that, no matter who your credit card processor is, you can make sure that you are receiving the best value possible in this growing part of your business.

- Check your effective rate! The effective rate can be calculated by dividing the total amount you paid to your processor (all rates AND all fees) by the total dollars ran in credit card charges. For reference, Best Card's average practice nationwide pays an effective rate of 2.14%.
- Many processors attach an expensive early termination fee to their contracts, as well as expensive long-term leases for credit card processing equipment. This means that they can raise rates at will because they can make it too expensive to leave, so we always recommend asking for the early termination fee unambiguously in writing. Furthermore, a lease will generally cost you four to twenty times more than the value of the equipment if you were to buy it outright

• To lower your effective rate, try to take as many debit cards as possible and, if insurance carriers will cooperate, try to take insurance payments via check or ACH instead of credit cards (we often see these card rates run at highest costs). The Durbin Amendment to the Dodd-Frank Act of 2011 lowered the cost of debit cards for all credit card processors. Your processor should offer significantly lower rates on debit cards than credit cards, even without entering a PIN number; if they don't offer lower debit rates, you need to contact them to make sure you aren't overpaying. With much lower debit cost, even a simple step like getting your staff to ask patients if they have a debit card they would like to pay with can lead to significant monthly savings. Furthermore, any card accepted in person (swiped or dipped using the chip) not only runs at a lower cost, it also gives you a much stronger position in case of a chargeback issued by the patient; if possible, always try to accept payment at the time of treatment. If a payment is later keyed-in due to the card or patient not being present, always put in the address, zip code and 3-digit security code on the back of the card to ensure the lowest possible rates and strongest possible chargeback position on keyed cards.

A quick review of your current service can save you thousands of dollars per year in this fast-growing sector of your business!

The ADA launched April 3 an online search tool aimed to help prospective patients connect with local ADA

"This campaign is designed to help our members succeed by helping fill holes in their schedules," said Dr. Craig Herre, chair of the ADA Council on Communications. "It will only succeed if members participate by completing their profile so that consumers have a good tool to use."

Profiles with photos receive 11 times more clicks on average than those

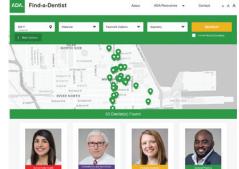
without, Dr. Herre said. Members are able to see how many times their profiles have been viewed through their My ADA member dashboard.

The focus of a three-year initiative to drive utilization of dental services for Association members, the Find-a-Dentist search tool allows a person to enter their street address or zip code and locate ADA member dentists nearby.

A variety of new search criteria have been added to enhance the user experience, including payment options and dental specialty. Patients then contact the practice via email or phone and make appointments.

The utilization initiative also includes funding for paid search, ensuring that when targeted consumers look for a dentist on Google and other search engines, the ADA Find-a-Dentist tool comes up toward the top. Paid digital advertising was scheduled to start May 1.

The ADA House of Delegates approved the initiative, Resolution 67H-2016, at its October 2016 meeting following a comprehensive eight-month research initiative conducted by the ADA Division of Integrated Marketing and Communications and the Health Policy Institute to identify the ideal consumers for the campaign.

## Make Sure Your Website Is Disabilities Act-Compliant

Claims that websites violate the Americans with Disabilities Act appear to be on the increase for dental offices. If you have a website you may similarly be at risk.1 While the task of putting your website into full compliance may require some time and expense, there are certain steps that can be taken in the short term. The ADA has offered some ideas on some things you can do now to decrease the risk of a claim:

- Add an "Accessibility Link." Add a link (similar to the website's privacy policy) that links to a page that tells individuals with disabilities what to do if they can't access something on your website. Train your staff to respond effectively to requests for assistance.
- Talk to Website Designer. Ask your website designer if the website is accessible as designed and implemented. In addition, ask what must be done to make accessible the content you add yourself.
- Take Down, Evaluate, and/or Replace Website. If the
  website is not accessible, or if the designer doesn't
  know whether or how to make it accessible, you may
  wish to: temporarily take down the website; and/or have
  the website evaluated by a qualified consultant; and/
  or replace it, at least temporarily; and/or work with a
  website designer to create a new, accessible website.
- Adapt your Contracts. Make sure any contract for a new website requires the website developer to provide a site.

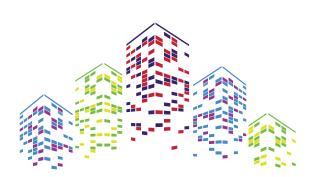
