# **ADA Announces Its New Opioid Policy**

The American Dental Association recently announced a new policy on opioids, supporting mandates on prescription limits and continuing education in what could be the first of its kind among major health care professional organizations.

#### The policy states:

- The ADA supports mandatory continuing education in prescribing opioids and other controlled substances.
- The ADA supports statutory limits on opioid dosage and duration of no more than seven days for the treatment of acute pain, consistent with the Centers for Disease Control

# From The Executive Director's Desk: Survey Results

On behalf of the Maine Dental Association Executive Board, I want to thank the membership for their participation in the recent MDA Membership Survey. In January 2018, we developed a short survey to collect input from members on what you value most about MDA membership and what products/services/benefits you believe are most beneficial and what options we might explore.

The data was collected by paper and electronic survey methods. An incentive of a \$150 gift card was used to help increase response rate. The lucky winner of the gift card was Dr. Stacey Stevens. Congratulations!

We received a total of 120 responses. All survey data was calculated in an aggregate format and no individual names have been recorded. A summary of the results of the survey is below. The MDA Executive Board will utilize this data, in concert with other resources, to help inform strategic planning discussions for the future.


# **Membership Survey Summary**

#### **Demographics**

Total of 120 dentists completed the survey. The total number of years practicing as a dentist in Maine ranged from less than one year to 50 years, with an average of 5.8 years. A total of 82 individuals or 68% of respondents practice general dentistry.

With respect to anticipated retirement age, 112 respondents answered this question. More than 35% of the survey participants said they plan to retire in 16 or more years, followed by 29.46% who said they plan to retire in 3-5 years.

#### **MDA** Membership


We asked respondents to tell us what is most important to them about their MDA

membership. We provided participants with 11 possible options to rank in terms of the level of importance (see graph at bottom left). The top three most important reasons why dentists who responded to the survey say they belong to the MDA included:

- · Support the profession
- Advocacy
- · Professional credibility

The lowest-ranking responses were:

- Purchasing products
- Insurance



#### Cost of Membership

With regards to the cost of MDA Membership relative to other professional dental association memberships, 54.7% of respondents said it was about the same; 5.98% less than; and 39.32% said it was greater than.

### **Member Benefits**

Survey respondents were asked to check off all of the Member benefits utilized in the last 12 months. The most popular benefit at 72.73% was continuing education programs, followed by professional liability insurance, 32.73%, and the MDA health insurance plan at 20%.

The least-utilized benefits include MDA Peer Review Program (3.64%), Appleby Student Scholarship program (3.64%) and the Glove Program (9.09%). The "Other" category was not reflective of any additional member benefit and in this instance was used more as a comment line.

As you are probably aware, the American Dental Association and CVS Pharmacy announced a three-year oral care collaboration to help put millions of Americans on a path to better overall health. Below are some common questions you may have about this initiative and a response from the ADA.

## Why is the ADA collaborating with CVS?

The ADA is dedicated to educating the public about importance of oral health and good dental health habits. CVS has a long-standing reputation for prioritizing the health and wellness of its patrons through its product offerings and in-store education efforts and reaches hundreds of millions of people each year. Joining our two organizations together can make a tremendous impact on improving oral and overall health.

#### What does the ADA/CVS collaboration include?

The collaboration includes continuous in-store and digital awareness of the ADA and the ADA Seal of Acceptance, to help millions of people improve their oral and overall health. Dental care products that have received the ADA Seal of Acceptance — from mouth rinses, toothbrushes, toothpastes, floss/interdental cleaners, and sugar-free gum — will be easily visible whether people are visiting CVS in-store, online or browsing through promotional flyers. Consumers visiting a CVS store will also be provided with credible oral health information and encouraged to use the ADA Find-A-Dentist online resource.

#### Is the collaboration exclusive, and why CVS?

The ADA is exclusively working with CVS for the duration of the three-year initiative, which began in January 2018. CVS has a well-documented track record of initiating programs that demonstrate a lasting commitment to improving the health and wellness of the public. From their efforts to reduce disseminating prescriptions of potentially addictive pain medications to their decision to no longer sell tobacco products, bettering the health of its customers is always a top priority. Additionally, CVS has nearly 8,000 individual stores nationwide, so it's an easily accessible place for people across the country.

# Is there any cost to states for the collaboration?

The ADA is not contributing anything financially to CVS in this collaboration.

## Doe CVS purchasing Aetna affect this collaboration?

Per our contractual agreement, the ADA collaboration with CVS does not include any dealings with Aetna, or any other benefits company. The proposed CVS acquisition of Aetna is a separate CVS business venture that is not

a part of our collaborative efforts.

This collaboration will continue to unfold with upcoming seasonal marketing, instore signage promoting products with the ADA seal, and ongoing strategy and planning sessions with manufacturers. CVS is considering the possible placement of kiosks within their stores for consumer use.

On another important note, last year our Board recognized the need to reimagine the ADA's business model to ensure that the ADA remains viable and financially stable into the future. While the ADA is in a strong position financially now, this project is focused on planning ahead to secure the well-being of the Association. Based on that recognition, we launched the business model project — a new, innovative business line to drive non-dues revenue.

We have been working with a consulting group, Continuum Innovation, based in Boston. Continuum has worked on a number of innovative initiatives for established companies, including development of the Swiffer and the Reebok Pump. Continuum is in its third round of field research doing qualitative interviews – this time in Texas. Field research has uncovered a need in the marketplace for new dentists and established dentists who want to connect for mentorship but have had difficulty doing so. Solving this problem would be of great value to both parties and ensure the transfer of knowledge between generations within the profession.

Field research has uncovered another need in the marketplace of established dentists having trouble finding a quality buyer for their practices. While solving this problem is challenging, preliminary research indicates that it is possible for the ADA to play a role in facilitating these transitions. There are additional needs around learning basic business management and/or ownership skills as well as services to help with patient acquisition, purchasing, staff relations, etc. This phase of the business model project is on track and under budget.

In March, Continuum was expected to provide a report to the Governance Team, who will then make a recommendation to the ADA Board of Trustees at its April meeting about whether or not to proceed with developing a pilot project to be tested in a willing constituent and component dental society. This recommendation will include cost projections and establish a basic business model. After the Board of Trustees makes its determination about next steps, it will share information more broadly.

# Oasis Dental Clinic Continues Growth Following Expansion

The Oasis Dental Clinic's growth has accelerated greatly since it opened its new, expanded location in Brunswick in June 2016.

Those eligible for care at the free adult clinic have to meet three criteria: They need to have no health or dental insurance, have a total household income at or below 200 percent of the Federal Poverty Level, and live in the area. Patients are pre-screened for eligibility and before they see a provider, they have a complete set of x-rays taken and an electronic record generated. The clinic is open during the day on Mondays, Wednesdays, and Fridays, and on Tuesday evenings. Now in its 13th year, the clinic was housed in the Jessie Albert Dental Center in Bath until June 2016. when it opened its new facility, located in the same building as the Oasis Health Center. Oasis Free Clinics, founded in 1992 and funded through individual donations and grants, and which accepts no state or federal funding, received a substantial grant from the Next Generation Foundation of Maine that provided the impetus for the new location. Volunteer dentists and hygiene staff offer their time and expertise.

Since opening its new location, the Oasis Dental Clinic has had 1,415 patient visits, and the value of donated services has totaled \$585,307. In that time, the clinic has had 49 hygiene clinics and 178 dental clinics, extracted more than 900 teeth, placed more than 500 fillings, and performed more than 200 dental cleanings.

Dr. Rick Elsaesser, Dental Director for Oasis Free Clinics, said the dental clinic is appreciative of the volunteers it has that travel from different parts of the state, but is always looking for more.

"Even though our patients come from the Mid-Coast area, we have volunteer providers from Portland to Hampden to Auburn," Elsaesser said.

Anita Ruff, Oasis Free Clinics Executive Director, said the need for dental services continues to grow at the facility.

"While our medical clinic intake has remained steady, we are seeing an increase in our dental clinic," Ruff said. "We are getting around 25 calls each month from people who are not currently eligible for our dental services, which led us to identify ways that we can serve those with health insurance but no, or limited, dental coverage."

Ruff said Oasis Free Clinics is piloting a project in partnership with Mid Coast Hospital that allows those who have been treated for a dental emergency to be referred to Oasis.

Volunteer providers said they value the time they give at Oasis, and are happy to provide care to those who need it.

"We restore not only patients to full dental health within our scope of means, but also to emotional, mental and physical health by meeting their dental needs," said Tammy Tyree, dental assistant. "We are helping to put peoples' confidence back in themselves, which overflows to their families and workplace."

Dr. James Oshetski, a volunteer dentist, said the staff at the Oasis Dental Clinic is "friendly, accommodating, and motivated," and he feels "tremendous satisfaction" from this work there.

"As a clinician, I am able to volunteer at my convenience and with no stress on my private practice," Oshetski said. "The need is significant, as there are many Mainers who have no options for dental care and are suffering from chronic infections. Patients there are truly thankful and very appreciative of treatment, as you are their only option."

and Prevention evidence-based guidelines.

 The ADA supports dentists registering with and utilizing Prescription Drug Monitoring Programs (PDMPs) to promote the appropriate use of opioids and deter misuse and abuse.

"As president of the ADA, I call upon dentists everywhere to double down on their efforts to prevent opioids from harming our patients and their families," said ADA President Joseph P. Crowley, DDS.

Most opioids prescribed to patients in the U.S. are written by physicians and other medical professionals for management of chronic (long-term) pain. Dentists with an appropriate license may also prescribe opioids, and do so most often for management of acute (short-term) pain such as severe tooth decay, extraction of teeth, and root canals. In 1998, dentists were the top specialty prescribers of opioid pain relievers, accounting for 15.5

percent of all opioid prescriptions in the U.S. By 2012, that number had fallen to 6.4 percent

New data published in the April issue of *The Journal of the American Dental Association* (JADA) continue to shed light on opioid prescriptions from a dental perspective.

#### The data indicates:

- with Analgesic Medications Used in the Management of Acute Dental Pain: Authors examined five systematic reviews and concluded non-steroidal anti-inflammatory drugs (NSAIDs) such as ibuprofen and acetaminophen are equal or superior to using opioids for dental pain. The findings support the ADA's 2016 policy statement that dentists "consider [NSAIDs] as the first-line therapy for acute pain management."
- Opioid Prescribing Practices from 2010 through 2015 Among Dentists in the United States: Authors from the ADA Health Policy Institute used data in several existing databases to review opioid prescription claims

- from 2010 to 2015 for about 1.1 million privately insured dental patients. Findings indicate that patients who received an opioid prescription from a dentist were given a median supply to last three days. Across all age groups over a six-year period, opioid prescriptions increased by 17 per 1,000 dental patients. The largest increase in opioid prescriptions was among patients aged 11 to 18; and 11-18 and 19-25 age groups received a higher median dose than all other age groups.



2018, we felt it was important to obtain feedback from the membership.

# If yes, how difficult was it for you to find new coverage?



We asked survey respondents if they participated in the MDA health insurance plan in the last 12 months: 74.79% responded NO and 25.21% responded YES.

We then asked respondents to tell us how difficult it was to find new health insurance coverage, 15% said it was easy or very easy to find new coverage; 10.38% said it was hard; and 5.6% said it was very hard. The question did not pertain to 69.81% of respondents who were not on the MDA health insurance plan in the last 12 months.

Finally, we asked survey respondents about the cost of finding new coverage. A total of 109 dentists answered the question. The cost of a new plan compared to the MDA health insurance plan broke down as follows:



We asked survey respondents if they had attended the MDA Annual Convention in the last two years. 54.1% said YES and 45.9% said NO. Additionally, we asked survey respondents to indicate if they had attended the CE program at Togus VA in the last two years. 43.8% said YES and 56.2% said NO.

The survey included a question about their preference for format of CE offerings. Respondents indicated that they are open to other learning opportunities than conferences. Online courses and smaller hands-on courses appeal to 53% and 39% of the respondents, respectively.

# Please check off all formats that you are interested in receiving MDA Continuing Education Programming:




We also asked participants to provide us with speaker and topic suggestions This information will be used to inform the Continuing Education Planning Committee's work as we make changes to MDA continuing education offerings.

### Advocacy/Legislative Efforts

Members were polled to rank the MDA's advocacy and legislative work on a scale of excellent to poor. Over 94% of survey participants said that the MDA's legislative alerts are excellent or good. Overall advocacy at the state level was rated by 91.5% of the respondents as excellent or good. Candidate fundraisers was rated as fair by 19.5% and poor by 2%.

Similarly, Political Action Committee (MDPAC) fundraising was rated as 15.24% fair; and 2.86% poor.



In conclusion, the MDA is the professional home for Maine's dentists. We represent nearly 90% of all Maine

licensed dentists. The benefits of professional membership associations across many disciplines often focus on professional development, education, and advocacy.

Our survey results zeroed in on three reasons why Maine dentists belong to the MDA. They include: support of the profession, advocacy on behalf of the profession and our patients, and professional credibility.

The MDA Executive Board and staff will use this data to help build more robust and diverse continuing education offerings in new and different formats, and we will also work to address areas such as broader member benefits and fundraising for political action purposes.

Again, we thank the membership for taking the time to participate in our survey and with grant support from the American Dental Association, we will be holding some listening sessions across the state this fall to hear more from young dentists and non-members about what would appeal to them in a statewide dental association.



# It's Oral Cancer Awareness Month, and Dentists Play a Role

April is Oral Cancer Awareness Month and a good time for dental professionals to consider their role in screening head and neck cancers and making referrals when appropriate.

The ADA offers resources on the topic of head and neck cancers based on the best scientific evidence.

In 2017, the ADA released a clinical practice guideline for the evaluation of potentially malignant disorders in the oral cavity.

It offers clinicians an overview about the potential use of adjuncts as triage tools for the evaluation of lesions, including potentially malignant disorders in the oral cavity. The guideline also offers six recommendations, including that all adult dental patients should receive an intraoral and extraoral conventional

visual and tactile examination when visiting their dentists.

To download and read the entire guideline, go to ADA.org/OralCancer.

The ADA Science Institute maintains a webpage on ADA.org about oral cancers, with data about incidence and mortality; information about risk factors, signs and symptoms; as well as links to other resources, including an instructional video demonstrating the patient intraoral and extraoral conventional visual and tactile examination for oral cancer.

Dentists can use the Patient Page in JADA to help facilitate a discussion about lesions that might be oral cancer. To view this, visit JADA.ADA.org and search for "Oral Cancer: What To Do If Something Unusual Shows Up."

Dentists can also refer patients to the ADA's consumer website, MouthHealthy.

org, for general information about oral head and neck cancer and human papillomavirus. Check ADA News in April for more information about oropharyngeal cancer and HPV.

An ADA CE course about HPV-related orophayrngeal cancer is available online.

Dental professionals can also purchase brochures for their patients related to oral cancers.

# Dental Providers Encouraged to Check Reports on Water Quality

Dental professionals are encouraged to check their community's annual Water Quality Reports or Consumer Confidence Reports, which water suppliers nationwide are required to make available each year prior to July 1.

The reports give consumers the chance to check on the status of their community's water, including its fluoride levels and details about quality and content of the water.

Annual Consumer Confidence Reports are the easiest source on actual fluoride levels that dentists can reference, according to Kip Duchon, national fluoridation engineer at the Centers for Disease Control and Prevention. "A provider needs to understand a patient's total fluoride exposure and fluoride in drinking water is the largest contributor to total fluoride exposure," Duchon said.

The U.S. Environmental Protection Agency requires water systems to post these annual reports at EPA. gov/CCR. Consumers can also visit the "My Water's Fluoride" page on the Centers for Disease Control and Prevention website, CDC. gov, to check on local water system fluoridation status.

The most recent statistics from the CDC indicate that nearly 74.4 percent of the U.S. population on community water supplies — or about 211.4 million people — received the benefit

of fluoridated water in 2014. However, coverage can vary significantly between states.

The ADA Council on Advocacy for Access and Prevention offers resources and training opportunities for dentists in communities working to initiate or retain fluoridation. # What is the CDCA and the ADEX Exam? Here's More Information

The CDCA (Commission on Dental Competency Assessments), formerly the NERB (North East Regional Board of Dental Examiners), is a testing agency that administers the ADEX (American Board of Dental Examiners) exam.

Some years ago, the ADA Council on Dental Education and Licensure and the American Association of Dental Examiners invited all regional testing agencies, as well as independent states, to attend a meeting in Chicago in an attempt to establish a single initial licensure examination. At this meeting, ADEX was developed. ADEX is essentially an examination development committee comprised of one individual from every participating ADEX state, with the sole purpose of developing the content, scoring, and criteria for initial licensure in both dentistry and dental hygiene.


ADEX develops the examinations, and the testing agencies (such as CDCA) administer those exams. The active state boards have direct input into the development of the examinations that they agree to recognize. A state board's only responsibility is to the citizens of their state, and, as such, licensure with examination was developed as a mechanism to protect the public from incompetent individuals.

At present, unlike the original NERB, candidates' work is evaluated independently and anonymously by three evaluators. The ADEX examination consists of a computer-based exam that evaluates an applicant's knowledge of oral pathology,

radiology, pharmacology, etc. There is also a non-patientbased mannequin portion that evaluates two endodontic procedures, as well as three material-specific crown preparations. And finally, there are three separate patient-based procedures - periodontal scaling, a posterior class II, and an anterior class III preparation and restoration. All procedures must be passed in order to achieve ADEX status. Compensatory scoring allows averaging of scores, so what would be a failing grade by itself can become a passing overall grade when averaged with a second procedure that is not recognized by ADEX.

The ADEX exam is the most universally accepted initial licensure exam, and is presently administered by both CITA (Council of Interstate Testing Agencies) and CDCA. Today, the CDCA has 30 member jurisdictions,


