## From The Executive Director's Desk: Listening To And Expressing Concerns

In the association world, summer is the time of year when business slows down, but that was not the case at MDA this summer. It was a very busy summer for the MDA and me. I had the pleasure of visiting three component meetings in September and meeting members in person throughout the state. I enjoyed listening to everyone's concerns regarding dentistry in Maine. Of course, the biggest concern is workforce issues and the new mandate for the COVID vaccine for health care workers. I can tell you that the board of directors, our lobbyist, and myself are doing everything we possibly can to express your concerns to the governor's office and DHHS. You have strong leaders within the MDA board, and they have been very active on your behalf.

I've learned a lot about Maine politics and the rulemaking process within the last month. As you know, Gov. Mills announced the health care workers' COVID vaccine 90-day emergency mandate in August, and then DHHS came out with the proposed ruling in September. DHHS had their public hearing on this ruling on September 27, and the written comment period ended October 7. MDA submitted written comments focusing on some possible changes, like aligning with the federal mandate and forthcoming OSHA rules, and advocated for a testing option, particularly in instances where practices or facilities are short staffed, causing patient cancellations or temporary closures. The MDA also requested additional time to continue efforts to identify and educate dental office staff and to train new staff members. I've been working with the department's legal team to get answers to our members' questions, and they've continued to update the FAO page on their website with their answers, but they are very vague.

Now the comment period has ended, the agency will make a formal decision on the proposed rule. Adoption, if that is

the decision, must be by official action of the agency, and must take place within 120 days from the comment deadline.

MDA has implemented a new employment assistance program to assist our members in searching for staff members. Our staff will be working with local community colleges, dental assistant programs, and hygiene programs to gather information of those individuals' search for jobs. We are also using social media to find individuals interested in working in the dental field. Please see our website for more information on this program.

Please take a chance to look over the MDA's newly revised continuing

education curriculum.

The MDA Continuing Education Committee has surveyed the members and is trying to give most of the members what they are looking for in continuing dental education. They have found top-ranked dental educators to give lectures and then, following up the lectures with in-person study groups discussing treatment planning using the methods taught at the prior education session. These in-person treatment planning sessions will be held a couple of weeks after the lecture. They will be held in Portland, Augusta, Bangor, and possibly Presque Isle. More information on the treatment planning sessions will be given at the first CE course on October 29 in Hallowell at Maple Hill Farm Inn and Conference Center. The lectures will be available in person and virtually, but you need to sign up soon! Take advantage of package plans that offer three education courses, along with the treatment planning sessions and one course at the Annual Convention. Please note - the treatment planning sessions are optional, but they are an added benefit to the education sessions.

Thank you to all of you who have called the office, sent emails, and talked to me in person expressing your opinions and comments on how MDA can best serve our members and be the leaders in oral health in Maine.

## **News from the President's Corner**

It hardly seems possible that summer has come to an end and the cooler weather is already upon us.

While summer normally provides an opportunity for us all to catch our breath, it definitely did not feel long enough

to put wind in our sails. The stress and burnout of running a business, managing a team, fulfilling patient expectations, all while trying to create perfection in an environment that is less than perfect, is a challenge to say the least.

Over the past couple of months, the dental team has been at the forefront of our minds, as each team member impacts the success of patient care. This is an opportunity for us to reflect on how important our teams are to us as clinicians and as business owners.

With many of our offices in need of extra hands, I would like to share a few things that work well in my office to keep morale up and to keep momentum going.

- 1. Appreciate your team by demonstrating their value as partners in the success of the practice. When one of my team members has a win, big or small, I like to thank them by leaving a note at the end of the day in their operatory or at their workstation. When they come to work the next day, they see the memo and it starts their day on a positive note.
- 2. Set meaningful and realistic goals for your office. It's a great way to motivate the team to work together and provide incentive for meeting goals, both in and out of the office.

3. Be available for your team. Sometimes there isn't enough time in the day. Take time outside of your regular business hours to check in on your team and connect with them individually or together. Every morning, my team meets to review the schedule, check in on office and personal goals, but, most importantly, to check in on each other.

Sometimes we will have a spontaneous happy hour or walk after a long week. These times are especially important to allow the team to unwind and not take their work home with them.

4. Celebrate the little things. Each small win you celebrate will bring a more positive energy to the office.

Remember, a good team is made up of good people who are good at their jobs. A great team is made up of people who are not only good at their jobs, but have also

been instilled with a deep understanding of how their contributions are part of a larger purpose.

It is also important to acknowledge that the dental team isn't just those in our office, but our community partners, allied health care professionals, and, most importantly, our fellow dentists. Not only do we need to have compassion for our patients, but also for our team members and for our colleagues. I remember reaching out to fellow colleagues when our offices were preparing to reopen, to ask how they were making changes to be compliant, about any resources that helped them. ## **News from the First District Trustee's Corner**

#### **Three Periods**

The summer has drawn to a close, and as your friend and First District trustee, I hope each of you had an opportunity to take some time off, relax and spend time with your loved ones. We now enter what we expect to be a busy fall, with ADA SmileCon, the First District Caucus and the ADA House of Delegates. A great deal is on our plate, many of which weigh heavily for organized dentistry. Here are just a few of those issues.

FIRST PERIOD: With the concept of "Medicare for all," there exists both an enormous challenge and a great opportunity for organized dentistry. We have all heard the political rhetoric associated with the general issue of Medicare expansion, but very few policymakers and stakeholders have the knowledge of oral health care to create a viable and affordable dental benefit within this system.

Dr. Klemmedson, our ADA president, has eloquently and consistently communicated the ADA's proposals, which the ADA Board wholeheartedly supports. These proposals represent the tremendous opportunity in our hands, but only if our membership answers the call and shares these proposals with their respective Congressional delegations. Policymakers need to hear how they can make this idea a reality and help our neediest seniors without inadvertently damaging how dentists care for their patients. Our lobbyists are working nonstop to advance these proposals, but we need you, as legislators' constituents, to help drive home these important points.

**SECOND PERIOD:** Recently, many political leaders, taking notice of nearly static vaccination rates across the country, have pushed for mandated vaccinations for health care workers, including dental professionals. President Biden has called for such a mandate for any health care professional who works with Medicare and Medicaid populations.

The ADA strongly encourages dental professionals to

get vaccinated, a policy we have maintained since the vaccine first became available in 2020. We have not advocated for mandates, however, due in large part to the fact that we already face a nationwide shortage of qualified dental staff (namely hygienists and assistants) and a blanket mandate would likely worsen that shortage. ADA and state societies continue to push for every dental professional to get vaccinated. To help, we are speaking the language of dentistry: science- and data-based information about the safety and efficacy of the vaccines. To be sure, dentists must continue to educate both patients and our own team members on getting vaccinated and, in the meantime, continue to follow the protocols that have safeguarded dental practices nationwide from in-office transmission.

THIRD PERIOD: Last month, the ADA lost a friend and a leader, Dr. Jonathan Shenkin of Maine. He was a lion – brilliant and the consummate oral health advocate. As a pediatric dentist in the greater Augusta area, Jonathan was warm and caring, always keeping focused on the health of his young patients (and their families). As a leader of organized dentistry, Dr. Shenkin took the passion for his patients' oral health to the regional and national stage. The ADA First District and the ADA owe a tremendous debt to Dr. Shenkin for his commitment, leadership, and knowledge.

On a personal note, Jonathan was a good friend, with whom I had many spirited discussions and debates over the years. He admitted to me on many occasions with that wry smile that he sometimes enjoyed "stirring the pot," but his zeal was never misplaced. He always stood on the side of dentistry and our patients (both of which are inextricably linked), employing a set of ethical and professional standards to every aspect of his career. We will all miss you, Jonathan. I know I do.

As always, it is a great honor to serve as your trustee. I look forward to seeing you throughout New England in the coming months!

of membership (or 40 total years) and have attained the age 65 years of age during the previous calendar year. The Council explored removing the age requirement so that the requirement is based solely on years of membership. This change would allow members to achieve life membership status sooner, doubling the number of current life members in the first year of the change. Life members would continue to pay full dues and receive special discounts and services as a life member until retirement at which they would pay \$0 as a retired life member. This change will have a small financial implication. The Council presents the following resolution to the 2020 House of Delegates for its consideration."

Resolution passed by ADA 2020 HOD changed this language in the ADA Bylaws:

68. Resolved, that the ADA Bylaws, Chapter I. Membership, Section 20.

Membership Eligibility, Subsection B. LIFE MEMBER, be amended as follows (deletions stricken and additions underlined):

- B. LIFE MEMBER. Any person holding a D.D.S., D.M.D. or equivalent degree shall be eligible to be a life member of this Association if he or she meets the following qualifications:
- a. Has been an active and/or retired member in good standing of this Association for at least thirty (30) consecutive years or a total of at least forty (40) non-consecutive years; and b. Reached the age of at least sixty-five (65) during the previous calendar year; e.b. Maintains membership in good standing in a constituent and component, if such exists, and in this Association.

d.c. A member may also qualify for life member status by having been a member of the National Dental Association for twenty-five (25) years and subsequently holding membership in this Association for at least ten (10) years and having reached the age of at least sixty-five (65) during the previous

calendar year.

#### MDA Bylaws proposed changes:

LIFE MEMBERS. A Life member shall be a member in good standing who has been an Active and/or Retired member in good standing for thirty (30) consecutive years or a total of forty (40) years of Active and/or Retired membership in the American Dental Association and has attained the age of sixty-five (65) years. Life membership shall be effective the calendar year following the year in which the requirements are fulfilled. The American Dental Association will give notification to members who are eligible for Life membership. To qualify for Retired Life membership status. the member shall submit an affidavit attesting to the member's qualification for Retired Life membership through appropriate component and constituent societies, which constituent shall submit certificates verifying such qualifications to ADA.

## No-Cost CDC Resource Outlines Infection Control for Dental Settings


#### **ADA NEWS**

## Updated COVID-19 Vaccine Fact Sheet Available From ADA

The ADA has updated its COVID-19 Vaccination Fact Sheet to give dentists and dental team members the latest information on COVID-19 booster shots.

The U.S. Food and Drug Administration authorized a third single booster dose of the Comirnaty vaccine to be administered 6 months after the primary series for specified populations.

Comirnaty was previously known as the Pfizer-BioNTech vaccine and is FDA-approved as a primary vaccination series for all individuals 16 years of age and older.
