Legislative Update: What MDA Is Tracking

The second regular session of the 130th Maine Legislature is rapidly approaching its April 20 statutory adjournment. While most committees have completed their work, votes on hundreds of bills now in the possession of the House and Senate

will occur over the next few weeks. The Appropriations Committee continues its work on the general fund supplemental budget and the highway fund supplemental budget; additionally, the Appropriations Committee will vote on whether to fund the nearly 200 bills on the special appropriations table, many

April JADA Finds More Than 1 in 5 US Adults Have Untreated Caries

More than 1 in 5 U.S. adults have untreated caries, and those with a family income at or below the poverty threshold are at a disproportionately high risk of being part of that group, according to a study published in the April issue of The Journal of the American Dental Association.

The cover story, "Update on the Prevalence of Untreated Caries in the US Adult Population, 2017-2020," used data from the 2017-2020 National Health and Nutrition Examination Survey to derive estimates for untreated caries prevalence in the U.S. adult population. Author Nasir Zeeshan Bashir, B.D.S., a research fellow in the University of Bristol School of Oral and Dental Sciences in England, conducted subgroup analyses to assess how the disease was distributed among population subgroups and how the epidemiology differed between coronal and root caries.

The study found the prevalence of untreated caries to be 21.3%, based on a weighted sample representative of 193.5 million U.S. adults. Caries was most prevalent in those with a family



income to poverty ratio of less than 0.5 or 0.5-1.0, as well as men, those aged 30-39 and 40-49, those of other or non-Hispanic Black race or ethnicity, those with an educational attainment less than high school graduation, those who did not have health insurance, and those who were underweight or obese. The prevalence of coronal and root caries was 17.9% and 10.1%, respectively.

Other articles in the April JADA discuss the effectiveness of aerosol reduction strategies, tobacco smoke exposure and children's oral health, and outpatient dental visits during the COVID-19 pandemic. Every month, JADA articles are published online at JADA.ADA.org in advance of the print publication.

- Committee on Peer Review and Ethics

The MDA Board of Directors has approved the changes, which are now up for review by members, who will have the chance to approve them at the member meeting during the convention. That meeting will be held on Saturday, May 21 at 4:45 pm.



of which were carried over from last Session. And there are more bills with fiscal notes to come. Bills which remain unvoted when the 130st Legislature adjourns will not be carried over to the 131st Legislature.

Many of you may remember the medical loss ratio for dental insurance bill, LD 1266 - An Act to Add Value to Dental Insurance, sponsored by Sen. Heather Sanborn in 2021 and carried over to this session. After a great deal of work with the Bureau of Insurance, dental insurers, and other interested parties, a significantly amended version of LD 1266 received a unanimous ought to pass committee vote. A solid piece of policy, the bill establishes a medical loss ratio reporting requirement for dental plans and requires carrier-specific annual loss ratios to be published on the Bureau of Insurance's publicly available website. The bill also directs the Bureau of Insurance to calculate an aggregate average loss ratio by market segment

over a three-year period to identify and review dental plans that have loss ratios which deviate from those averages. The bill further gives the Bureau of Insurance authority to order identified outliers to file remediation plans. While we did not get all we wanted, LD 1266 was passed to be enacted in both the House and Senate and was on its way to Gov. Janet Mills' desk. Sen. Sanborn paid tribute to Dr. Jonathan Shenkin, who led the charge on LD 1266, during her remarks on passage.

We also saw a unanimous ought to pass committee vote on LD 665 - An Act to **Provide Better Dental Care to Cancer** Survivors - the bill was heading to the House and Senate. LD 665 requires a study to determine that the change in law was not an addition to the state's essential health benefits, which would require that the state defray costs. The bill requires health plans to include coverage for dental procedures that are medically necessary to reduce the risk of infection or eliminate infection, or to treat tooth loss or decay, in an enrollee prior to beginning cancer treatment, or that are the direct or indirect result

of cancer treatment The requirements apply to all health plans issued or renewed on or after January 1, 2023. Maine will become the first state to pass legislation requiring health plans to cover necessary dental treatment for cancer patients. Special thanks to Dr. Rob Berube and Dr. Rebecca Berry for their work on this significant piece of legislation.

The biennial budget which passed last year included allocations for a MaineCare adult dental benefit, as well as funds to implement rate increases on MaineCare dental codes. These are the allocations that are effective on July 1, 2022:

Money allocated in the biennial budget for MaineCare dental rate increases:

- \$2,846,428 General Fund
- \$5,753,752 Federal

Money allocated in the biennial budget for MaineCare adult dental:

- \$12,266,233 General Fund
- \$30.060.311 Federal

The MaineCare Advisory Committee's Dental Subcommittee continues to work on these critical initiatives; additional information will be uploaded to the MDA website.

In June 2021, the governor signed into law LD 76 - An Act To Amend the Dental Practice Act To Define "Supervision" and Authorize Teledentistry.

As a result of the law, on March 25, the Maine Board of Dental Practice convened a group of stakeholders to assist in identifying teledentistry guidelines and practice standards to ensure public safety and protection. Dr. David Wicks participated on behalf of the MDA.

The following link provides a wealth of information on teledentistry, as well as a draft of "Practice Requirements For Teledentistry Services," which can be viewed on pages 450–454 at https://www.maine.gov/dental/board-

information/stakeholder-meetings. html. The Board of Dental Practice is planning to discuss the draft and subsequently undertake rulemaking.

Lastly, I want to thank all of you who continue to provide invaluable guidance, testimony, and support. A special acknowledgement goes to MDA Council on Government Relations Chair Dr. Mike Dowling and CGR members Dr. Rob Berube, Dr. Moe Convey, Dr. Brian Patterson, Dr. Dean Tourigny, Dr. David Wicks, and Dr. Karl Woods.

While we worked on and monitored numerous bills throughout the session, many are still in the process of moving through the Legislature. A bill tracker, which includes all the bills we've followed will be posted on the MDA website in the members-only Legislative Updates section.

The tracker includes links to bills, along with other information. Once the Legislature adjourns, I'll update with the final posture of each bill and include links to final bill language.

6 CDT Code Category Updates Approved

The Code Mantenance Committee approved updates to six CDT Code categories at its March annual meeting that include seven COVID-19 vaccination codes, six diagnostic imaging codes and codes for the administration of human papillomavirus vaccinations.

While the CDT Code set already includes COVID-19 vaccination codes from previous years, this is the first time the HPV vaccine administration receives a code designation, said L. King Scott, D.D.S., chair of the Code Maintenance Committee.

In all, the committee approved the addition of 29 new codes, as well as 14 revisions and two deletions.

The newly approved COVID-19 vaccination codes are effective immediately, meaning they are officially part of the CDT 2022 code set.

Other CDT Code actions approved

during the meeting will be in CDT 2023, which goes into effect Jan. 1, 2023.

The other Code actions approved by the committee include:

- Six diagnostic imaging codes for tomosynthesis, as well as bitewings and periapicals
- Six guided tissue regeneration procedure codes that enable documenting delivery to a natural tooth, an implant, or an edentulous area
- Four new codes to document 3-D dental and facial surface scanning procedures

Maine Dental Education Loan/Repayment Program - Apply by May 31

Are you a dental student from Maine who will practice in Maine, a licensed dentist who practices in a qualifying Maine practice, or a licensed dentist who intends to practice in Maine?

The Finance Authority of Maine (FAME) administers two programs designed to increase the number of primary dental care practitioners providing services to underserved populations in Maine.

For the Student

The Maine Dental Education Loan Program is a competitive, forgivable loan program for Maine students pursuing a career as a dentist and planning to work in Maine after graduation. Recipients may receive loans of up to \$25,000 per year, \$100,000 total.

To be eligible for this loan, the student must be a Maine resident (for purposes other than education) for two years prior to matriculation at a dental school; admitted to a program of dentistry for a first DDS or DMD degree at an accredited institution; show an interest in practicing primary dental care in an underserved population area in Maine and in serving patients regardless of their ability to pay; and demonstrate financial need.

Priority is given to eligible applicants with the greatest financial need and a demonstrated intent to practice primary dental care in an underserved population area in Maine. The loan does not enter repayment or accrue interest until the student has completed their professional education and has forgiveness provisions for borrowers who meet the return service criteria.

For the Practitioner
The Maine Dental Education Loan
Repayment Program provides loan

repayment assistance to dentists practicing in underserved population areas in Maine. This repayment program requires a minimum two-year commitment, which is renewable for an additional two years and provides up to \$25,000 for repayment of existing dental education loans for each year of service for up to four years or \$100,000 total.

To be eligible for this loan repayment program, a dentist must be eligible for licensure to practice dental medicine in Maine; have qualifying outstanding education loans; be able to document employment at a qualifying dental care facility; practice at any health care facility that offers primary dental care as either its primary service or as part of a broader medical practice in an underserved population area; accepts payment through MaineCare or a successor program; have at least 25 percent of the patient load that has

been accepted for treatment regardless of ability to pay through insurance or other payment source; and a dental care facility must provide patients notice that it accepts payment through MaineCare or a successor program. Qualifying applicants cannot be under an agreement for loan repayment from

a program funded by the National Health Service Corps.


