
MDA Board Officers Elected; Changes To Bylaws Approved

Different Starting Points

Over the next 11 months, I hope to begin a conversation with all of you. I suspect that some of you may be wondering how the executive director of a small nonprofit children's dental clinic up in Northern Maine will possibly represent the interests of all Maine dentists. I understand that MDA is all of us. Having been in private practice and

now in public health dentistry, I hope I can indeed represent all of us, with the goal of excellence in dentistry for all MDA members and excellent oral health for all Mainers.

As a very young girl, I began work on our family farm as a potato picker. I was about four-and-a-half years old. I picked alongside my older siblings and my mom. We each had a basket. We bent over the rows of freshly dug potatoes, picked them, and filled our baskets. We then emptied the basket into a potato

barrel set up in our picking section. Nowadays, most farms use highly mechanized methods of harvesting potatoes, some of which don't require manual labor at all for the picking process.

As a four-year-old of small stature, you might imagine that my ability to contribute to the picking process was limited. However, adjustments were made, and I could add to the day's production quite nicely. One of the most important adjustments was the size of my basket. At the beginning of the season, each picker received a new basket. There were baskets of all sizes available, and fortunately one that fit me just fine. It was an adaptation that allowed for me to participate in the harvest season. In addition, I had well-fitting gloves with which to work, and older siblings who recognized that sometimes they'd have to help me empty my basket into the barrel as it was taller than I was.

In other words, I had a support system. There were adaptations made so that I could be part of the harvest, and so that the overall process was equitable. If I hadn't had the smaller basket that I could actually lift and carry, I could not have contributed to the process, and I could not have earned my new sneakers that fall.

The fact that I have this story to tell was dependent on many more factors than I will relate here, such as a mom

who picked alongside me and always made sure I had good food in my belly. However, it helps me present a thought: not everyone begins or began at the same place. Not everyone began at the same place.

I was able to participate in an important part of our local economy because I was provided the tools I needed. The farmer recognized that not all pickers were the same size,

so different sizes of implements were needed - baskets, gloves, and even the length of the picker's section were considered.

In today's society, there are still many examples of how we don't all start at the same place, or with the same resources available to us. In dentistry, we have a long way to go to achieve oral health equity for all. One example is well laid out in this infographic: www.cdc.gov/oralhealth/publications/docs/DOH-

Report-Graphics-two-H.pdf. Certain groups of adults have twice as much untreated decay as other groups of adults (low-income vs. higher income; less than high school education vs. more than high school education, etc.)

There are many reasons for health inequity: social determinants of health (food and housing insecurities to name just a couple), socioeconomic and culture-based disparities, and many others. As part of the dental profession, it's imperative that we recognize the inequity and reasons for it so that we can learn how best to address the oral health needs of our communities.

We can't just give everyone the same size basket and expect that everyone will be able to pick those potatoes. Maybe we can adjust and meet our patients where they are, at their starting point.

Sometimes adjustments can be made, and the potatoes get picked.

ADA Considering Strategic Forecasting Model Over Strategic Planning

Earlier this year, a special task force of American Dental Association delegates from each trustee district was charged with evaluating that business model and determining, if necessary, how best to improve the association's processes to enable innovation, speed, and transparency. The task force observed that a modernized business model for the ADA would require the support of a nimble governance process.

The task force made its recommendation to the ADA Board of Trustees: Evolve the ADA's governance from a five-year strategic planning model into a dynamic strategic forecasting model that would empower the ADA to act quickly in response to change, deliver member value in real time, and remain on course

towards its long-range goals.

With unanimous approval of the task force's recommendation, the board has submitted a report to the 2022 ADA House of Delegates proposing a shift from strategic planning to a strategic forecasting model for ADA governance.

Strategic forecasting confers three important changes the ADA's current framework:

- The House of Delegates will focus on its highest and best use and establish the association's multi-year strategic forecast
- A new Strategic Forecasting Committee — as an entity of the House — will work year-round to

refine the strategic forecast and facilitate immediate action when it's needed most, based on the ADA's current environment and emerging member needs

 The Board of Trustees manages the budget in support of the strategic forecast as determined by the House. Funding toward the ADA's strategic programs and initiatives (which will continue to be led by ADA councils) will be reallocated as needed.

At the ADA House of Delegates in Houston in October, delegates will have the opportunity to ask questions and share their perspectives on the governance change at their caucus meetings and during a town hall event.

The proposed rule and the emergency rule updating Section 25 of the MaineCare Benefits Manual will have different prior authorization requirements.

The emergency rule effective July 1 does not include certain prior authorization requirements for which there was not clear consensus from pre-rulemaking consultation with stakeholders and department clinical resources.

The proposed rule, which will go into effect in its adopted form no more than 90 days after the emergency rule, includes all prior authorization requirements the Maine Department of Health and Human Services initially recommended in pre-rulemaking consultation, in alignment with standard practice by state Medicaid agencies nationally. Including these new requirements in the proposed rule allows for further public comment

STATE TELEDENTISTRY RULES ON TABLE

The Maine Board of Dental Practice is planning to take up proposed new rules for teledentistry in the state.

The proposal for Chapter 15, "Practice Requirements for Teledentistry Services," can be found on the board's website at www.maine.gov/dental.

According to the Board of Dental Practice, "This is a new rule identifying the practice requirements when dental professionals licensed by the Board utilize teledentistry services. This rule proposal includes language specific to definitions, general requirements, scopes of practice, supervision and delegation, privacy and security, emergency services, codes of professional conduct, technology and equipment, and patient disclosure requirements."

The deadline for public comment on the proposed rules is July 31 at 5 p.m. A public hearing has not been scheduled yet. The MDA will keep members updated regarding details for the public hearing.

Anesthesia Proposal Withdrawn By Board

At its June 24 meeting, the Maine Board of Dental Practice reviewed public comments received on the proposed changes to Chapter 14 – specific to dentist requirements when utilizing a certified registered nurse anesthetist as part of a 14-day agreement. Upon review and discussion of the public comments, as well as ongoing efforts to update the sedation rules to reflect current guidelines to ensure patient safety, the board voted to withdraw the rulemaking proposal.

In a separate vote, the board directed board staff to draft proposed rulemaking language for its July 15 meeting that would require advanced life support certification requirements. The requirements would be not only for the operating dentist, but to ensure the same life support certification requirements are identified for authorized sedation providers identified under Chapter 14.

This Year's Credit Card Brand Fee Changes And Your Bottom Line

Many businesses are unaware of the fact that card brands (Visa, Mastercard, Discover, and American Express) all charge set fees, known as Interchange, when you process a payment. It's important to know that the card brands do regularly adjust their fees, normally every April and October. Female First-Year Dental Students At Highest Ever

Women made up 56% of first-year dental students in 2021 – the highest rate ever, according to the ADA Health Policy Institute, which studied the latest changes in demographics of first-year dental students in the Commission on Dental Accreditation's Survey of Dental Education.

In addition, HPI found that first-year enrollment also increased among Black and Hispanic dental students compared to a decade ago, and decreased among non-Hispanic white dental students

According to the fall 2021 data, 49.5% of first-year dental students were white, the second consecutive year when enrollment among this group was less than half; 7.3% were Black (compared to 5.6% in 2011); 10.7% were Hispanic (compared to 7.2% in 2011); and 22.5% were Asian (compared to 23.8% in 2011).

HPI tracks demographic changes to study

ongoing workforce trends. According to HPI, gender, race, and ethnicity affect systemic differences in practice patterns, including ownership rates, affiliation with dental service organizations, Medicaid acceptance, practicing in a shortage area, and amount of hours practicing.

The gender shift is going to accelerate several trends, including practice consolidation and a shift away from practice ownership, according to HPI.

According to an HPI webinar in March, gender parity is projected to reach the dentist workforce in 2040, as more women pursue dentistry. Women made up 20% of the dentist workforce in 2005; 34.5% in 2020. Practice ownership also continues to decline, from 84.7% in 2005 to 73% in 2021.

These data were published in the 2021-22 Dental Education Program Enrollment and Graduates Report, a new HPI publication.



distributing its products and those currently on the U.S. market must be removed or risk enforcement action, according to the FDA.

JUUL Labs is an American electronic

cigarette company. According to the Associated Press, "JUUL launched in 2015 and within two years rocketed to the top of the vaping market. JUUL, partially owned by tobacco giant Altria, still accounts for nearly 50% of the U.S. e-cigarette market."

HPI Poll: Dental Practice Schedules Steady Over Past Few Months

Dental practice schedules have been steady in the past few months, with dentists reporting that on average their practices' schedules were about 86% full in June, compared to 88% in March, according to the ADA Health Policy Institute.

These results are part of the latest HPI Economic Outlook and Emerging Issues in Dentistry poll, which was conducted June 14-19.

Other key findings include:

- Staff recruitment continues to be a priority for dental practitioners, with roughly four in 10 dentists reporting that had recently or were currently recruiting dental assistants and dental hygienists as of June. Hiring dental hygienists continues to be the most challenging for dentists.
- Eight out of 10 dentists surveyed reported issuing pay raises for their teams in the past year. Recent wage increases have most commonly been in the 4-6% range.
- The most common benefits dentists

are offering their employees are dental benefits, paid vacation, paid holidays and retirement savings.

Each month, the ADA Health Policy Institute conducts a poll of U.S. dentists, Economic Outlook and Emerging Issues in Dentistry, to measure the economic impact of the COVID-19 pandemic and to gather their opinions on other current and emerging issues impacting their practices.
